 - a. Important Dates
 - i. Opening Ceremonies 3/16/2024
 - 1. Sponsors will be coming out for the day

 - b. Guaranteed Spots Rule and Sibling Guarantee
 - i. Recommendations were proposed for updating the Guaranteed Spots Rule and Sibling Guarantee due to the high player retention over the past few years. With the decline in municipality field availability, we are not able to add additional teams to the organization. With the expectation that field availability will continue to decline, the Organization needs to have the ability to control the quantity of players from league to league. The updates presented to the Board were accepted. The updated policy will be shared to the WRBA website with the opening of Fall 2024 registration.
 - c. Fall Restructuring
 - i. Fall 2024 end of season survey feedback had a heavy theme of participants not feeling the season was competitive. A proposal from the Baseball Committee to institute an American League/National League structure was presented to the Board. The Board had feedback on the policy and asked the Baseball Committee to make edits based on the feedback. The updated policy will be sent to the Board for a vote to approve. If approved, this policy will be updated on the WR website inline with the opening of Fall 2024 registration.
